LB 753 would set a dangerous precedent for tax policy

Public tax dollars should be reserved for use for education. public projects. The State Constitution has language Constitution

Article VII, section 11 of the Nebraska states: "Notwithstanding any other that affirms that position regarding the funding of public provision in this Constitution, appropriation of public funds shall not be made to any school or institution of learning not owned or exclusively controlled by the state or a political subdivision thereof."

LB 753, introduced by Senator Lou Ann Linehan at the request of the governor, attempts to do an "end run" on this constitutional provision. Simply put, LB 753 would allow any Nebraskan to send up to 50% of his/her Nebraska income tax liability to a nongovernmental, privately operated elementary or secondary school located in this state. That would potentially deprive the state of half of its income tax income (up to \$25 million the first year), while funding private school scholarships in violation of the constitution.

LB 753 would provide a non-refundable, 5-year carry-over tax credit for donations to qualifying scholarship-providing organizations. To qualify, the scholarship organization must provide qualifying education scholarships. Those qualifying education scholarships must be used to pay tuition and fees at a qualifying school. Qualifying schools are nongovernmental, privately operated elementary or updates on this and other bills. NSEA opposes LB 753. secondary school located in this state." The state

administers the issuance of the tax credits through a program that keeps the budgeted caps in place. The program starts with a \$25 million cap that gradually expands to \$100 million if people take advantage of the program. This legislation is part of a national effort to enhance school choice by extending public tax money to private schools.

Former State Senator Curt Friesen of Henderson opposes the bill. In an opinion piece, he said this: LB 753, a bill to send \$25 million to private schools through the guise of excessive tax credits for donations to scholarship granting organizations, will do next to nothing for rural Nebraska and our kids. Over the eight years I was in the Legislature and on the Revenue Committee, I worked hard to ensure rural Nebraska had a strong voice to protect the interests of property owners while still ensuring our students could access a great education. That's why I'm opposed to LB 753.

LB 641 speeds removal of Nebraska tax on Social Security income

Getting rid of the Nebraska income tax on Social Security benefits has been a priority of NSEA-Retired and other organizations representing seniors for about 20 years. Over time, we've gradually reduced the state income tax burden on the Social Security benefit. Three years ago a bill was passed that would eliminate the tax completely over ten years. Last year that process was accelerated to eliminate the tax in five years. LB 641, introduced by Senator Kathleen Kauth, at the request of the governor, would move elimination of the tax up by one year.

If LB 641 passes, 70% (instead of 60%) of your Social Security benefit would be exempt from state income tax for your 2023 tax filing, and 100% (instead provides background detail on bills that have been

Get updates on legislation

The new boundaries for Legislative Districts may have provided you a new senator in the Unicameral. You can find the name of your senator, and the contact information for him/her, by going to the Unicameral website, www.nebraskalegislature.gov. Click on the "Senators" link on the left side of the page to get a drop-down menu that allows you to enter your address and find the senator for your legislative district.

Do you want to keep current on what is happening in the Nebraska Legislature? NSEA prepares weekly updates on pending legislation and

lifetime members (the rest are annual members). Most became life members before they retired. You don't have to be retired to join the retired organizations! Lifetime members pay dues only once.

Active teachers can join NEA-Retired, NSEA-Retired, and OEA-Retired as pre-retired lifetime subscribers any time during their careers. Since lifetime dues have a tendency to go up over time, the sooner you become a lifetime member, the cheaper it will be! Current combined lifetime dues for all three organizations is \$600 (combined NEA-Retired and NSEA-Retired dues = \$500; OEA-Retired = \$100). The dues can be paid either in one lump sum, or in monthly deductions from your checking account.
