Oct. 21 meeting to be via Zoom – topics include OSERS update

The Delta variant of COVID-19 is now the prevalent strain of the virus. In an abundance of caution, OEA-Retired will hold its first meeting on the **OEA-Retired** website. www.OEAretired.org. When you open the Zoom meeting link, you will be placed in a virtual "waiting room" until the meeting is ready to begin.

The main speaker at the Oct. 21 meeting will be Cecelia Carter, OSERS Executive Secretary. Cecelia will give an update on the status of OSERS. LB 147, which passed the Legislature last year, transferred the management of OSERS to the OPS School Board while the retirement system prepares to transfer complete operation to the Nebraska Public Employee Retirement (NPERS) Systems

management. Additional details on the transfer can be found elsewhere in this newsletter.

There are several items that will need to be Thursday, October 21 via Zoom. The Zoom link can be addressed as the transition to management of the retirement system by the state is completed. Among them: When will retirement checks be sent to retirees? Currently OSERS pays benefits on the 3rd of the month for the prior month; NPERS pays benefits on the last working day of the month for that month. How will the COLA adjustments be handled? Currently OSERS pays the general COLA on a different schedule and using a different calculation method than does NPERS. How will the Medical COLA be addressed? NPERS does not have a Medical COLA benefit.

The 2021 Nebraska Legislature passed LB147, which transfers management of the Omaha School Employees' Retirement System (OSERS) back to the OPS Board for the next three years to prepare

the transition of management of OSERS to Nebraska Public Employees Retirement Systems (NPERS). Cecelia Carter will be at our October meeting to give an update on the transition.

We no longer elect our representative on the OSERS Board of Trustees. The OPS Board has appointed Jane Erdenberger to represent the OPS Board of Education on the OSERS Board. Jane is also a retired OSERS member. OSERS has authorized these individuals to sign legal contracts on behalf of OSERS: Patrick Bourne, Esq., Board of Trustees Chairperson; Jane Erdenberger, Esq., Board of Trustees Vice Chairperson; Cecelia M. Carter, Board of Trustees Secretary; James A. Ellis, Retirement Benefits Manager

LB 147 brings changes to Retirement System

The Omaha School Employees' Retirement System, OSERS, is changing quickly, thanks to the passage of LB 147 in 2021. LB 147 established a new governance system for OSERS with all of the trustees appointed by the OPS Board of Education.

The law created an interim Transition Board of Trustees consisting of two business persons who are not members of the retirement system; two OPS Board of Education members; two members of OSERS, one

of whom will be a teacher; and the OPS Superintendent. The Transition Trustees took office on July 1, 2021. The Transition Trustees are: Business Persons: Patrick Bourne and Scott Herschenbach; OPS Board members: Jane Erdenberger and Spencer Head; OSERS members: Faith Johnson (teacher) and Sharon Block; and OPS Superintendent Cheryl Logan. The OPS Board of Education trustees and member representative trustees serve one-year terms, with the

ability to be reappointed. The Transition Board will be dissolved when OSERS management and governance are transferred to the Nebraska State Retirement Systems on September 1, 2024.

LB 147 also mandated an IRS Compliance Audit to be completed by November 1, 2021. At the June 2021 OSERS Board meeting, Ice Miller, LLP was engaged to complete the Compliance Audit. Compliance Audit is performed to assure that the retirement system is adhering to recordkeeping and information reporting requirements of the Internal Revenue Service. Ice Miller, LLP is a nationally known law firm with headquarters in Indianapolis, IN. It was selected to do the work after reviewing competitive bids from three national law firms.

Once the Compliance Audit is complete, the Nebraska State Auditor will perform an audit of OSERS before OSERS management is transferred to the Nebraska State Retirement Systems. The State Auditor does all of the audits of the state retirement plans. OSERS currently uses the same auditor that is employed to audit the OPS accounts.

A number of details need to be finalized before the transition to the State Retirement Systems is OPS has agreed to pay for any costs associated with the transition. LB 147 did not affect any of the current benefits that OSERS provides for retirees.

Social Security tax relief bill passed into law!

Nebraska is one of just 13 states that taxes Social Security benefits, and has the highest tax on the Social Security benefit of any state in the seven-state region (NE, KS, MO, IA, SD, WY and CO). On May 20, 2021, LB 64, introduced by Omaha Senator Brett Lindstrom, was passed into law on a vote of 41 ave, 0 nay, and 8 excused and not voting. In fact, there was not a single "no" vote on any of the three readings of the bill! The bill will phase out the Nebraska state income tax on Social Security benefits over a ten-year time horizon.

Starting in the tax year that began January 1, 2021, taxpayers may claim a reduction in their federal adjusted gross income (AGI) for a percentage of their Social Security benefit. The exclusion begins at 5% of the Social Security benefit in 2021, and increases each year until 100% of the benefit is excluded in 2030. The table shows the actual percent exclusion for each year.

A coalition of retiree groups in Nebraska has worked for 20 years to reduce or eliminate the Nebraska income tax on Social Security benefits. The coalition immediate economic boost for every county in the state.

often cited a statement made by the Governor of Missouri when that state stopped taxing Social Security: "Social Security was intended to keep our elderly and disabled citizens out of poverty - it was never intended to be a source of revenue for the states."

Senator Lindstrom stated that when LB 64 is fully implemented, retirees on Social Security will pay approximately \$1,000 less in state income tax. Slightly more than 300,000 retirees in the state receive Social Security benefits. The money that is not paid in taxes will

Medicare information sessions scheduled – Omaha seminar is Oct. 20

To protect the health of members, the annual Medicare information seminars will be held with inperson seminars in Omaha, Lincoln and Kearney for limited audiences and six virtual sessions. Omaha in-person seminars, which will last about 90 minutes, will be held at the OPS TAC Building, 3215 Cuming Street, on Wednesday, October 20 at 9:30 a.m. with a repeat at 1:00 p.m. On-site registration will begin 30 minutes prior to the start of the session.

Six virtual seminars will be held on: Nov. 1 (4pm); Nov. 3 (9am); Nov. 8 (9am); Nov. 9 (2pm); Nov. 15 (2pm); and Nov. 16 (9am). The virtual seminars will last about an hour. To help facilitate questions, the virtual seminars will be limited to 30 participants per session.

The seminars will cover Medicare eligibility

and coverage as well as details on Educators' Medicare Supplement, the Medicare supplement endorsed by NSEA-Retired and underwritten by Blue Cross Blue Shield of Nebraska. Educators' Medicare Supplement has both Plan F and Plan G supplements. It is only available to EHA subscribers and/or NSEA-Retired members and their spouses when they turn 65. Educators' Medicare supplement pays for medical costs that Medicare does not cover, and it has an optional dental plan that is superior to any individual dental plan offered to Medicare subscribers.

Registration for the seminars is required. To register for any of the seminars, visit nebraskablue.com/nseaseminars. You will need a valid email address to register, and you will get a confirmation email when you register. You need to

register one week prior to the beginning of the seminar you choose. You may call Blue Cross at 877-721-2583 for assistance.

Pay your OEA-Retired dues now!

OPS Phase 2 Bond Update

Omaha Public School's Bond Program updates T are positive. Phase 1 is now complete. Phase 2 has Six completed projects; four are in closeout; 14 are in construction; and one out for bid/award.

Phase 1's total budget was \$424.3 million. The cost details are: Construction = \$334.7 million; Site Acquisition = \$32.97 million; Design = \$28.1 million; Misc. = \$20.1 million; FF&E = \$6.9 million; Contingency = \$871,000.

The Phase 2 budget is \$409.9 million. As of August 2021, 60.21% of the budget has been spent. The middle school at 42nd and Y now has a name: Bluestem Middle School. This name was selected because:

- Bluestems are deeply rooted, anchored and enriched plants.
- Bluestems reflect who we are as a South Omaha community.

Omaha Public School's Bond Program updates The school colors will be Navy Blue, Hunter Green, and itive. Phase 1 is now complete. Phase 2 has Silver:

- Navy Blue represents strength, reliability, bravery and honor.
- Hunter Green represents safety, calmness, relaxation. Green is the color of life, growth, health and nature.
- Silver represents accomplishments, value, and a vision of a successful future. It symbolizes innovation and communication with confidence.

The Bluestem School mascot will be the Mighty Meadowlark, which is Nebraska's state bird.
