Oct. 20 meeting to hear concerns on OSERS transition to NPERS

LB 147 mandated that the management and governance of the Omaha School Employees' Retirement System (OSERS) be transferred to the Nebraska Public Employee Retirement Systems (NPERS), with the transfer to be completed by September 1, 2024. The bill created an interim board of trustees to facilitate the transfer, and charged the OPS Board of Education with making all final decisions regarding OSERS during the transfer process. steering committee has been established to manage The steering committee transfer. representatives from OPS, OSERS and NPERS.

Jane Erdenberger, the current OPS Board of Education Vice President and a retired OPS teacher, has been appointed as one of the OSERS Transition Trustees. Jane has volunteered to attend the October 20 meeting of OEA-Retired to collect any questions and hear any concerns or feedback on the transition.

There are several items that will need to be

addressed as the transition to management of the retirement system by the state is completed. Among them: When will retirement checks be sent to retirees? Currently OSERS pays benefits on the 3rd of the month for the prior month; NPERS pays benefits on the last working day of the month for that month. How will the COLA adjustments be handled? Currently OSERS pays the general COLA on a different schedule and using a different calculation method than does NPERS. How will the Medical COLA be addressed? NPERS does not have a Medical COLA benefit.

The Thursday, October 20th meeting will be an in-person meeting at the OEA Office, 4202 S. 57th Street, from 10:00 a.m. to 11:30 a.m. Following CDC guidelines, face masks are optional for this meeting. UNL Osher Lifelong Learning awaits adults this fall

Insights into the Nebraska State Prison across Nebraska, many of whom live in Omaha, OLLI System, archaeological excavations to uncover ancient Rome and the founders of the American Republic, why public health matters, and a conversation about the Ukraine. These are among the varied courses to be offered by the Osher Lifelong Learning Institute at the University of Nebraska-Lincoln (OLLI at UNL) during its second term this fall beginning in October. There are 125 OLLI programs across the country - all are affiliated with an institution of higher learning in their state.

OLLI at UNL is a membership-based program specifically designed for adults age 50 years and older who appreciate that curiosity never retires. In addition to noncredit courses and events, OLLI offers travel opportunities to places across the United States and internationally. OLLI is about the love of learning. No tests. No grades. No problem.

The ability to connect via Zoom has expanded the OLLI at UNL program. "For the last couple of years, we have been delivering programs online through live Zoom stream and on demand through a platform called Canvas," said Bob Michl, director of the OLLI at UNL program. "We strive to deliver programming which where they live."

OLLI at UNL has members in 62 communities

offers courses in-person in a classroom, via live-stream on Zoom, and on-demand. Programmed, on-demand classes are recorded courses where you watch on your own time and at your convenience.

Registration for the second term begins October 11 with classes starting October 24. Annual membership is \$75. Each OLLI class has a one-time charge of \$10. Courses that are longer than one session have an additional \$5 per session charge. Programed, on-demand classes are offered as a package of several courses for a single fee of \$30.

"Fall is a great time for lifelong learners to reconnect for stimulating lectures and conversation," said Michl. "Our fall symposium this year is focused on global food security. We have speakers from the World Food Bank in Africa, a senior researcher from the International Food Policy Research Institute in Washington, D.C. and the past president of Bread for the World who will be our speakers." Participants can attend in-person or live on Zoom. The symposium takes place on Saturday, October 22, at UNL's East Campus Union in Lincoln.

Omaha Medicare information sessions on Nov. 10

Blue Cross Blue Shield of Nebraska will once again host Medicare information seminars around the state. Four in-person seminars will be held in Omaha, Lincoln, Norfolk and Kearney. The Omaha in-person seminars, which will last about 90 minutes, will be held at the OPS TAC Building, 3215 Cuming Street, on Thursday, November 10 at 9:30 a.m. with a repeat at 1:30 p.m. On-site registration will begin 30 minutes prior to the start of the session.

Four virtual seminars will be held on: Tues., Oct. 25 (2 pm); Thurs., Nov. 3 (9 am); Mon., Nov. 7 (2 pm); and Wed., Nov. 9 (9 am). The virtual seminars will last about an hour. To help facilitate questions, the virtual seminars will be limited to about 30 participants per session.

The seminars will cover Medicare eligibility and coverage as well as details on Educators' Medicare Supplement, the Medicare supplement endorsed by NSEA-Retired and underwritten by Blue Cross Blue Shield of Nebraska. Educators' Medicare Supplement has both Plan F and Plan G supplements. It is only available to EHA subscribers and/or NSEA-Retired members and their spouses when they turn 65. Educators' Medicare supplement pays for medical costs that Medicare does not cover, and it has an optional dental plan that is superior to any individual dental plan offered to Medicare subscribers.

The same information will be provided at all of the seminars, whether in-person or virtual, so you only need to attend one of the seminars to get full information. Registration for the seminars is required. To register for any of the seminars, visit nebraskablue.com/NSEAseminars.

You will need a valid email address to register, and you will get a confirmation email when you register. You need to register at least one week prior to the date of the seminar you choose. You may call Blue Cross at 877-721-2583 for assistance.

WOW! Thanks to the 2018 Bond Program, the Omaha Public Schools opened four new schools this school year. I was able to attend all four Dedication Programs. These programs were attended by many

parents, students that would be attending these schools, as well as interested citizens who voted *yes* for the Bond Program. Each school has its own unique design, lots of windows for natural lighting, brilliant technology, bright colors, and modern furniture to meet the needs of every student. I could go on and on about how these schools will meet the needs of the future. If you can, take time to visit one of the new schools.

Buena Vista High School, located at 60th and L, has a 1500 student capacity. It will also be home to a YMCA Express outfitted with outstanding exercise One World Clinic is also located on equipment. campus. Westview High School, located at 156th and Ida Street, has a 1500 student capacity. A YMCA is located on this campus through a partnership with the Omaha Public Schools. OPS contributes space for a cycling studio child watch and YMCA offices needed to run their program at Westview. In turn, the YMCA contributed funds to support the construction of an aquatics center consisting of a six-lane swimming pool with spectator seating and a leisure pool area. YMCA and OPS share access to the auxiliary gym. which will offer many activity options. Both new high schools started the year with freshmen and sophomores. Juniors will be added in 2023 and seniors in 2024.

Pine Elementary School, located on 10th and seen some green Pine, has opened and has a 600 student capacity. It has an enormous gym as they were able to refurbish the gym from Grace Bible College. High schools may reserve practice time in the gym. Forest Station, Public schools.

located at 1000 North Fort Crook Road, has a 600 student capacity. When you walk into the school, you are reminded of the forest as its color scheme was chosen from forest greens, blues, brown and other nature colors. Bluestem Middle School, located at 42nd and U Street, has a 1000 student capacity. It is the last new school being built and will be ready for the 2023-2024 school year.

Older schools were not forgotten in the 2018 Bond Program. Adams, Catlin, Conestoga, Edison, Highland and King Elementary Schools all received capital improvements (capital improvements increase the building system effectiveness). Edison had its safe room turned into two classrooms, and three more rooms were added; Highland received an eleven-room addition; Masters added four rooms; Pinewood added three classrooms; and Spring Lake had a ten-room addition.

Middle Schools receiving capital Improvements and additions were Lewis and Clark (15 rooms were added) and Morton (9 rooms added). High Schools that received capital improvements were Benson, Bryan, Burke, Central, North, and Northwest. South and Central High Schools have requested some work this fall.

The start of the 2022-2023 School year has seen some great improvements to the Omaha Public Schools' buildings. All this took place thanks to the Omaha citizens' approval of the 2014 and 2018 Bond Programs and the assistance of the staff of the Omaha Public schools.
